#### Submission Guidelines:

- 1.Papers can be submitted in Arabic, English, or French.
- 2. Submissions must demonstrate academic originality and adhere to scientific integrity.
- 3. Papers should not have been published previously or presented at another conference, and they should not be part of a thesis.
- 4. Submissions must relate to one of the above-listed themes.
- 5. Papers written in Arabic should use Sakkal Majalla font size 14 for the main text and size 12 for footnotes, while those written in other languages should use Times New Roman font size 14 for the main text and size 12 for footnotes, with 1.15 cm line spacing.
- 6. Papers should include abstracts and keywords in both Arabic and English, and the length of the paper should be between 15 and 25 pages.

Note: Peer-reviewed papers will be published in a collective volume.
